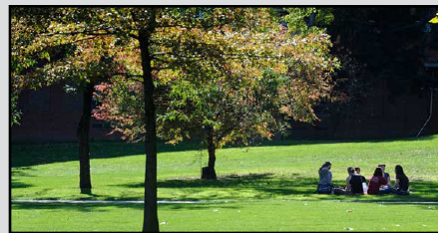

RESOURCES FOR DEVELOPING GRADUATE CURRICULUM

Graduate curriculum development is alive and well at IUP. Despite the challenging economic climate, I continue to be impressed by my colleagues who bring forward both

modifications to improve their existing programs and innovative new programs. Currently, there are more than a dozen NEW programs in the final stages of development and many more on the horizon. These include new CORs (Certificates of Recognition) as well as new Master's and Doctoral degrees that will provide high-quality instruction in emerging fields. Many of these programs include an on-line component to provide maximum flexibility in terms of reaching high-quality students and retaining them throughout the course of the program.

★ GRADUATE CURRICULUM TRACKING

The Graduate Curriculum Tracking log is also available on the SGSR website to assist faculty in knowing the status of their curriculum proposals. When a proposal arrives at the graduate school, the Dean's Associate adds it to the log and critical dates and actions are recorded as it moves through the process. Once it is approved by the Senate, the proposal is removed from the log. Recent SGSR progress *continued*

Last year's Board met many times in 2009-10 to discuss how centers and institutes should be evaluated. It is IUP Policy that each center and institute is evaluated every five years. However, no formal criteria had been established to do so. The committee created a draft of review criteria that was discussed during the fall and spring luncheon meetings with the center and institutes directors. These criteria were edited and improved based on these discussions, and were then presented in the annual Center and Institute Directors breakfast in the spring. The directors voted to accept the criteria. Dr. Hilliary Creely, Assistant Dean for Research, is working with this committee to review 14 centers and institutes this academic year.

FALL 2010 GRADUATE ENROLLMENT DECLINES

Enrollment in our graduate programs is down this fall compared to last fall. IUP has 2,299 graduate students enrolled this fall. This is a 2.0% decline in enrollment. Nationwide, graduate enrollment typically increases during economically difficult times. Applications to graduate school nationwide increased on average by 4.8% last year and graduate enrollment increased by 4.7% nationwide. So IUP's decline is definitely an anomaly.

The decline in graduate enrollment is in our master's programs, not our doctoral programs. Enrollment is up in IUP's doctoral programs, with

an increase of 9.8% compared with last year. Enrollment in master's programs declined by 7.4% students since Fall 2009.

Sponsored Activity News from The Research Institute

Research and other sponsored activities are doing very well at IUP. In FY09, YOU brought in nearly \$12 million in external funding! This is down just slightly from FY08 which is extremely impressive given the economic climate and is, obviously, the result of a lot of hard work and dedication.

Of that \$11,876,991, the majority or 57% came from Federal sources (NSE, NEH, DOJ, Education, NIH, etc); 20% came from the State of Pennsylvania (PDE, PASSHE, PA Dept of Labor, etc); and the remaining 23% came from nonprofit organizations, local government, and business/industry contracts.

Nearly \$12 million in external funds were received!

We are especially eager to see where FY10 will take us in terms of new opportunities and projects. Graduate School Program Spotlight

Ph.D. in Communications Media and Instructional Technology

The Ph.D. in Communications Media and Instructional Technology (CMIT) provides students an opportunity to combine theory, research and production in a blended program that combines traditional communications media and instructional technology. The program helps students develop abilities to conduct advanced academic and applied research. Students are also able to broaden their media development skills while being able to work on new media formats and applications.

The program requires a minimum of 60 credits, 48 course credits and 12 credits for the doctoral dissertation. Students are permitted to take classes on a full-time or part-time basis. Classes are typically offered in a blended format of online and face-to-face instruction and meet on weekends, five to six times during a semester. Some of the courses include Communication Research and Statistics, Ideas that Shape Media, Media Ethics, Media Production and Instructional Media Solutions. Students take courses in the three areas of research, theory and culture, and production.

Doctoral faculty in the Department of Communications Media have extensive backgrounds in broadcasting and mass communications, instructional design, organizational communication, and production; including video, audio, photography, graphics, animation, and video game production. The faculty are active in state, national and international organizations related to the field of communications and instructional technology and are well-published in related scholarly journals.

The CMIT program enrolled its first cohort of students in Fall 2008 and currently has almost 60 students actively enrolled. The program attracts students from a variety of professions including communication professionals, college faculty and administrators, and public school teachers.

Faculty Expertise Database

Many people, both on-campus and off-campus are asking these questions; and very soon, we will have some answers!

The mission statement of the SGSR reads: Indiana University of Pennsylvania (IUP) is a Doctoral Research University. As such, the School of Graduate Studies and Research provides strategic leadership for all graduate programs and for quality research and scholarship, within and outside the University. It also assists with marketing faculty talent and university capabilities to external audiences, and nurturing partnerships with outside agencies and businesses.

Representatives of the SGSR, the Office of Workforce Development and IT Services have been exploring ways to do just that – develop a database that will expand the marketing of the vast talents of our faculty. The good news is that we are 'nearly there.' With the help of the University Web Team, the tool to gather this information has 'passed' its first usability test. We are making appropriate modifications and plan to have the Faculty Expertise Data base available by the middle of the fall term.
